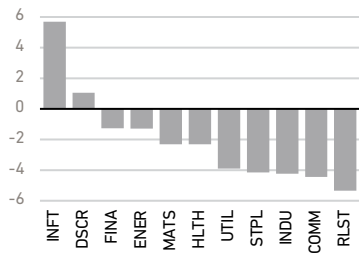

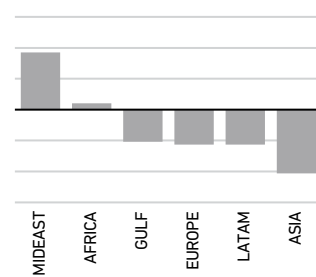

Total Return by Sector (%)

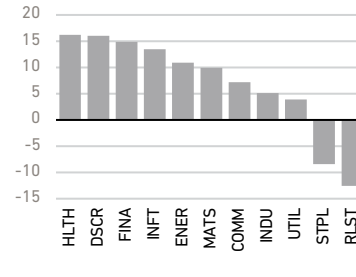


Total Return by Geography (%)

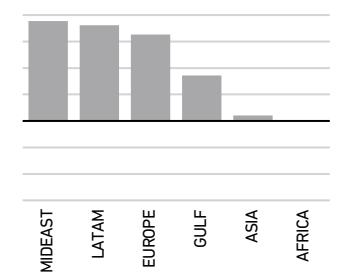

Total Return by Sector (%)

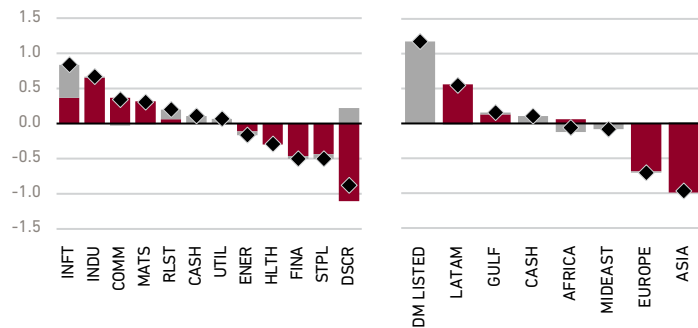


Total Return by Geography (%)
