The investment objective of the active Fund is to achieve long-term capital appreciation by investing primarily in equities of companies based in global markets other than the United States of America.

Our analysts conduct careful bottom-up research of individual companies and analyze the competitive dynamics of their industries to identify the best growth companies and to assess the value of their shares.
